### 4. Dues - Rick Dammers

- Motion: Raise ATMI Dues from \$40 to \$50
- Student Dues stay the same at \$20
- Reasons: Covers payment to JMTE and will help stem the monetary decline in the ATMI budget.
- Additional potential increase of \$5 in the next year depending on JTML publication.
- Discussion ensued.
  - Some wondered if it would be better to provide the benefit out of the reserve funds and wait until later for an increase.
  - Others indicated a \$10 increase would be okay.
  - One wondered if CMS would receive any additional income. That answer was no. In addition, someone wondered where the CMS registration fees go. They go to help fund the conference, rooms, equipment, etc.
  - O Jane Kuehne pointed out that many memberships are well over \$100 and ATMI is \$40 without having had

- an increase in many years.
- Jay Dorfman indicated that at \$10 increase would be in line with what TI:ME did. They also increased by \$10.
- Terry Ewell moved to approve a \$10 increase in dues. Brian Shepherd 2<sup>nd</sup> the motion. Unanimous approval by "I."
- o \$10 increase to begin in January, 2013.
